- Outline your understanding of the principles of environmental management & sustainability;
- Outline your knowledge and/or active experience you may have in, and understanding of, environmental and/or sustainability issues;
- Do you currently hold any relevant qualifications? If yes, please list any relevant current qualifications;
- Demonstrate your ability to develop links and liaise with the community - be it your local community or a particular community of interest.

In addition to the selection criteria consideration will be given to achieving, where possible, a balance of geographical representation across the Region and of the various target groups who experience barriers to inclusion.

Nominee applications will be assessed by a proposed panel consisting of Cr Zane O'Keefe, Cr George Seymour and the Executive Manager Strategy & Sustainability or appropriate proxy/ies. The nominee must ensure that they do not contact any of the panel members or any of its Personnel for the purpose of soliciting for the selection of the committee.
